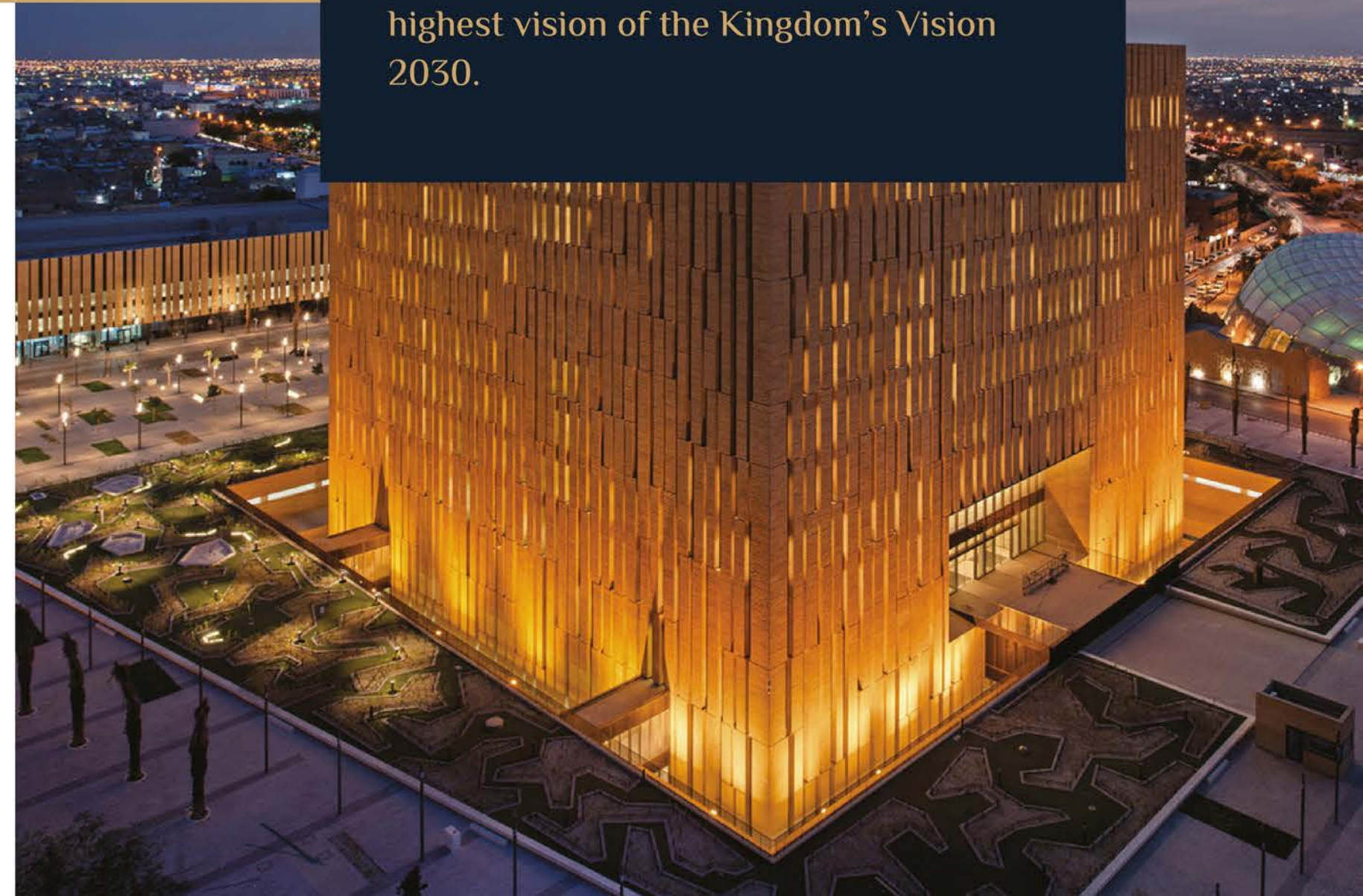

Steps for dealing with legal issues

Case Evaluation

Our legal team estimates the effort, time and resources required in an accurate and clear manner, through knowledge, experience and comparison with similar judicial cases.

Create Legal Strategy

Based on the case evaluation and legal research, we create a legal strategy to deal with your case, which includes determining appropriate legal procedures and future steps..



Data Collection

We collect detailed information including case details, relevant documents, and any additional details that help us fully understand the context of the case.

Overall Legal Search

We conduct overall legal research to collect the necessary legal information related to your case and make sure to verify judicial precedent, applicable laws and relevant legislation.

Preparing

We prepare for the case by collecting the necessary evidence and documents and preparing the required legal documents, such as power of attorney, complaints, lawsuits, or any other relevant legal documents.



Steps for dealing with legal issues

Settlement or trial procedures

We may seek to resolve the case through negotiations or arbitration proceedings, otherwise the case may continue in trial until a final court ruling.

Close the Case

After the implementation of the judgment is completed and all relevant legal issues are addressed, the case is closed and work on it is completed.



Initiating the Work

We initiate work on your case by submitting documents, pleadings and legal claims in the courts or before the relevant authorities, and representing you in the relevant sessions and negotiations

Implementation and following-up

After a final judicial ruling is issued in the case, the implementation of the ruling is followed up and ensured that it is applied correctly.

These are the general steps for receiving and starting work on a case, so it should be noted that the actual process may vary slightly, depending on the type and complexity of the case, and that these steps outline the general process of working on a legal case.

It is a principle that must be applied by companies seeking long-term sustainability and growth, and is also mandatory for entities wishing to list on the financial market.

Moreover, our work extends to contributing to the establishment and monitoring of all governance management and compliance operations in companies, particularly in publicly listed corporations.

Preparation for Offering in the Financial Market

The service of preparing for offering in the financial market aims to provide legal and advisory support to companies that wish to offer their shares. This includes starting with a preliminary examination to identify deficiencies and drawing up a work plan, followed by a legal due diligence process and completing the offering.

It also involves monitoring to ensure that operations are proceeding correctly and implementing all the necessary conditions set by the Financial Market Authority. Examples include: mandatory periodic announcements, holding necessary meetings, avoiding conflicts of interest, procedural aspects with related entities, and more.

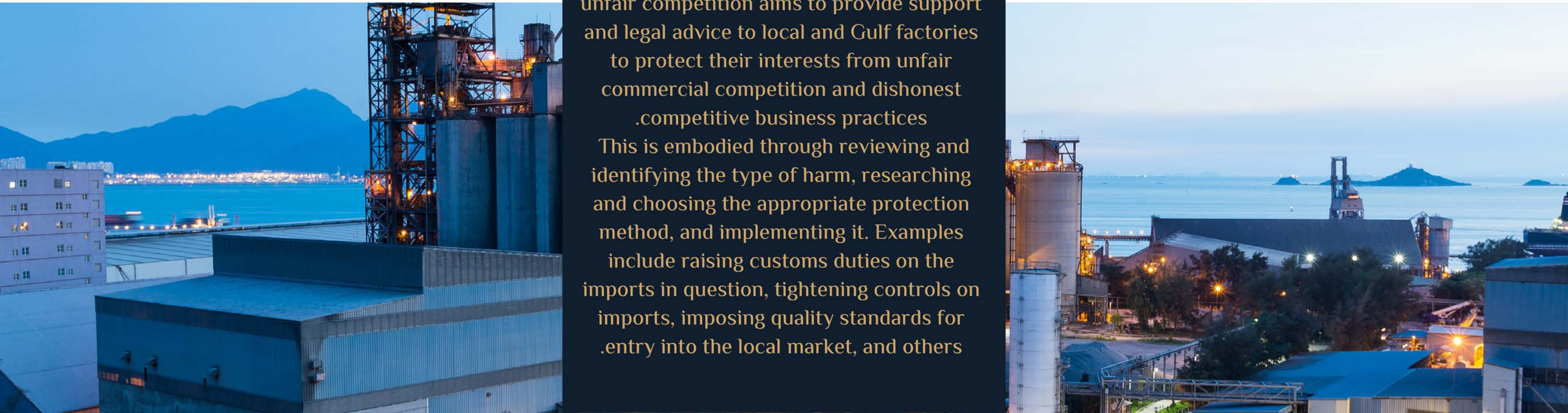


Office Services: Industrial Protection
